Personal Data Protection Policy

Hagihara Industries Inc. and its group companies ("we", "our", or "us") comply with laws and regulations and company rules and regulations, and our standard of corporate behavior is to build mutually trusted relationships with customers, shareholders, employees, business partners, and local communities by conducting socially equal corporate activities. We recognize that personal data protection is an important responsibility in promoting this and put into practice the "Personal Data Protection Policy" as established below.

- 1. Purpose of use
- The handling of personal data shall be notified to the person or used only to the extent necessary to achieve the purpose of use, except in cases permitted by laws and regulations.

2. Acquisition of personal data

• The purpose of use when keeping personal data is posted on the website. In addition, we only keep the personal data which is necessary to achieve the purpose of use and to the minimum level. If you do not agree with the purpose of use, please refrain from providing personal data.

3. Safety management measures for personal data

- We will take necessary and appropriate safety management measures against risks such as unauthorized access, loss, destruction and leakage of personal data.
- In order to ensure personal data protection, we will conduct the necessary and appropriate supervision towards our employees so that safety management is conducted.
- When outsourcing the handling of personal data to third parties, we will conduct the necessary and appropriate supervision towards the outsourced third parties so that safety management is conducted.
- We will strive to keep personal data accurate and up-to-date to the extent necessary to achieve the purpose of use.

4. Providing personal data to third parties

 Personal data will not be provided to third parties unless the consent of the customer is obtained or stipulated in the provisions of laws and regulations.

5. Disclosure, correction, suspension of use, etc.

• If the person (or his/her agent) wishes to disclose, correct, suspend the use, etc. of the

personal data of customers kept by us, we will promptly handle this to the extent reasonable and necessary. In addition, it may be necessary for you to bear the cost in the case of certain restrictions.

6. Compliance with laws and regulations, guidelines, etc.

- When handling customers' personal data, we comply with the Act on the Protection of Personal Information, other related laws and regulations, industry guidelines, etc.
- 7. Continuous review of privacy policy
- We will continuously review and improve our Personal Data Protection Policy. If the Personal Data Protection Policy is revised, the revised Privacy Policy will be applied from the date of publication of the revised version.
